(b)&(c): The Government has approved Provision of Urban Amenities in Rural Areas (PURA) Scheme for implementation on pilot basis in 11th Five Year Plan with the budgetary provision of Rs. 248 crore. The scheme proposes holistic and accelerated development of compact areas around a potential growth centre in a Gram Panchayat (s) through Public Private Partnership (PPP) framework for providing livelihood opportunities and urban amenities to improve the quality of life in rural areas. A notice was issued inviting Expression of Interest (EoI) from private sector entities on 15th April 2010 in leading national and financial dailies. In response to the notice, ninety three (93) EoIs were received out of which 45 organizations had qualified at the EoI Stage. The details of such 45 organizations are annexed. These 45 organizations were asked to submit the detailed bid alongwith concept plan by 07th October 2010. Nine organizations have submitted 14 proposals which are being evaluated by this Ministry. Once the evaluation process is completed, a clear picture about successful proposal and fund requirement will be available.
