- (b) whether it is also a fact that no worthwhile research is being undertaken in the Commission and the money allocated for the purpose is lapsing year after year;
- (c) if so, the reasons therefor; and
- (d) the action being taken to do the required research work?

- (a): Yes,Sir.
- (b),(c) and (d): During the last three years, eight research studies, including two ongoing, concerning minorities have been undertaken by National Commission for Minorities. A statement showing the studies undertaken during the last three years is annexed. The entire budget provision was utilized in 2007-08 whereas Rs. 12.96 lakh and Rs 4.14 lakh could be utilized in 2008-2009 and 2009-10 respectively against budget provision of Rs. 18 lakh each in both the years. The amount had to be surrendered because of inadequate response to the Notice Inviting Tender.
