(a) the targets fixed and achievements made under the welfare schemes for minorities being implemented by Government in the country during the last one year, scheme-wise and State-wise; and

(b) the number of persons belonging to minority communities benefited under these schemes during this period, State-wise?

(a) and (b) The targets fixed and achievements made under the following welfare schemes for Minorities being implemented by this Ministry during 2014-15 is as under:

Following are the reasons for increase in targets of the schemes mentioned above:

Nai Roshni: The target of 40000 was projected keeping in view the proposals for non-residential and residential training both. But there was no proposal received for residential training in 2014-15 which has the higher cost. Therefore, the Ministry was in position to cover more number of trainees under Non Residential component.

Seekho aur Kamao: 20000 was the projected target and the Ministry could achieve 20720 within the available funds.

Schemes implemented by NMDFC: The Public Sector Undertaking signs an agreement with the Ministry regarding targets and achievements. If they, achieve the targets fixed by the Ministry, they get very good rating. However, if they exceed the targets, they get outstanding rating. Further, under the above schemes, the NMDFC has optimized utilization of its internal resources by recovering more loans thereby making available more funds. Also, NMDFC covered more beneficiaries by giving lower quantum of loans per beneficiary.

Under the above schemes, the funds are not released state-wise. The State-wise details of number of trainees under 'Nai Roshni', 'Seekho Aur Kamao', and beneficiaries under NMDFC Schemes are placed at Annexure **I, II and III** respectively.

Under the Scheme of Multi-sectoral Development Programme (MsDP), no physical target is fixed. Projects are approved on the basis of the project proposals received from the States/UTs as per their requirement and felt need. Out of the total allocation (Revised Estimates) of Rs. 770.94 crore for MsDP during 2014-15, Rs. 767.86 crore were released to the States/UTs. as per Annexure-IV. Under MsDP, assets are created for the welfare of the community as a whole except for the projects of IAY, solar lantern, bicycle for girls, skill training to minority youths and cyber gram initiative which are for individual. The State wise details of the said projects approved during 2014-15 are at Annexure – V.

This Ministry implements following 7 schemes for Educational Empowerment of notified minority communities across the country:-

1. Pre-Matric Scholarship
2. Post-Matric Scholarship
3. Merit-cum-Means Scholarship
4. Maulana Azad National Fellowship.
5. Free Coaching & Allied Scheme.
6. Support to minority candidates clearing Prelims conducted by UPSC/SSC, State Public Service Commission (PSC) etc.
7. Padho Pardesh- Interest Subsidy on Educational Loans for overseas studies.

The details of targets fixed, fund released and achievements made under the above mentioned schemes during the last one year, State-wise is at **Annexure-VI, to Annexure-VIII**.

Following are the reasons for increase in targets of the schemes mentioned above:

Padho Pardesh: The targets was projected at 100 keeping in view the budget earmarked. More number of beneficiaries could be covered under the scheme on account of receipt of lower quantum of interest subsidy per beneficiary.

Free Coaching and Allied Scheme: More beneficiaries could be covered under the scheme on account of the following:

- a) Inclusion of additional 1000 students under New Component of the scheme.
- b) Availability of more funds at RE level for implementing the scheme.

Under the Scheme of Jiyo Parsi, no physical target was fixed. Against the financial target of Rs.2 crores for the year 2014-15, expenditure of Rs.50 lakhs was incurred. Further, under this Scheme, funds are not released state-wise.
