PMGSY PROJECTS IN HIMACHAL PRADESH

2666. SHRIMATI VIPLOVE THAKUR:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) the number of villages covered and those which are yet to be covered to provide rural connectivity under the Pradhan Mantri Gram Sadak Yojana (PMGSY), State/UT-wise;
- (b) the total length of roads constructed under various phases of the scheme, during the last three years in Himachal Pradesh, district-wise;
- (c) the details of funds allocated, sanctioned, released and the expenditure incurred under various phases of PMGSY during the said period in Himachal Pradesh, district-wise;
- (d) whether the work on certain projects under the scheme is running behind schedule in Himachal Pradesh; and
- (e) if so, the details thereof and the reasons therefor?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

'Rural roads' is a State subject and the works under Pradhan Mantri Gram Sadak **(a)** Yojana (PMGSY) are executed through State Governments. Under PMGSY, the unit of programme is a habitation and not a revenue village. A habitation is a cluster of population, living in an area, the location of which does not change over time. Desam, Dhanis, Tolas, Majras, Hamlets etc. are commonly used terminology to describe the Habitations. The programme envisages connecting all eligible unconnected habitations with a population of 500 persons and above (as per 2001 Census) in plain areas and 250 persons and above (as per 2001 Census) in Special Category States (Arunachal Pradesh, Assam, Manipur, Meghalaya, Mizoram, Nagaland, Sikkim, Tripura, Himachal Pradesh, Jammu & Kashmir and Uttarakhand), Tribal (Schedule-V) areas, the Desert Areas (as identified in Desert Development Programme) and in Selected Tribal and Backward Districts (as identified by the Ministry of Home Affairs (MHA). The PMGSY permits upgradation (to prescribed standards) of existing rural roads in districts where all the eligible habitations of the designated population size have been provided all weather road connectivity. In the critical LWE affected blocks (as identified by MHA), additional relaxation has been given to connect habitations with population 100 persons and above. Out of a total of 6374 works (roads & bridges) sanctioned, 6452 works have been completed and 282 works are in progress in PMGSYState/UT-wise details of habitations covered and yet to be covered under PMGSY are at Annexure A.

(b) : Year-wise/district-wise details of roads constructed under various phases of PMGSY in Himachal Pradesh during the last three years is at **Annexure B**.

(c) : Year-wise/district-wise details of funds allocated, sanctioned, released and expenditure incurred under various phases of PMGSY in Himachal Pradesh during the last three years is at **Annexure C**.

(d)&(e): State of Himachal Pradesh has reported that as on date, 829 PMGSY works are under progress, out of which, 137 works are pending for more than 2 years. The state has attributed reasons for delay of these 137 works to the following reasons:

i.Delay in award of works due to recall of tenders due to single bidders in the first call.

ii.Limited working season in the higher reaches and snow bound areas. Roads in such areas require longer time for completion.

iii. Delay in obtaining forest clearance.

iv.Since PMGSY does not have provision for land acquisition, the state obtains land as voluntary donation from private land owners, inconsistent decisions of land owners and land disputes also lead to delays.
