Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether Government has assessed the performance of Maharashtra in implementing the Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) in the State;
- (b) if so, the details and outcome thereof; and
- (c) the action Government has taken or proposes to take to rectify the shortcomings found during the assessment?

ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

(a) to (c): The status of implementation of Mahatma Gandhi National Rural Employment Guarantee Scheme (MGNREGS) is reviewed on a regular basis of all States/UTs including Maharashtra. National Level Monitors, Common Review Missions and Officers of the Ministry visit States at regular interval to review implementation of the programme. After the field visits, the findings/shortcomings and recommendations are shared with the States for appropriate action at their end. Performance review committee meetings of the Ministry and regular video conferencing on specific issues are also important tools of monitoring. The performance of the State of Maharashtra during the last three years and current year 2017-18 (as on 15.03.218) is given at **Annexure**.
