#### MINIMUM DAYS OF WORK UNDER MGNREGA

### **2672. SHRI NARESH AGRAWAL:**

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) whether it is a fact that the annual expenditure incurred by Government for providing 100 days employment under MGNREGA is much less than the budgetary provision;
- (b) if so, the reasons therefor and manner in which Government maintains a balance between them; and
- (c) the details of number of persons expected to be employed and the number of those actually employed under MGNREGA during the last three years?

## ANSWER MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT (SHRI RAM KRIPAL YADAV)

(a)&(b): The Mahatma Gandhi National Rural Employment Guarantee Act (MGNREGA) provides for at least 100 days of wage employment to every rural household whose adult members are willing to do unskilled manual work. During FY 2016-17, 39.91 lakh households have been provided 100 days employment under MGNREGS.

(c): State/UT-wise details of employment offered to Individuals and employment provided to Individuals under the MGNREGS during the last three years is given at **Annexure**.
