PROGRESS OF SPMRM IN WEST BENGAL

2679. SHRI DEREK O'BRIEN:

Will the Minister of **RURAL DEVELOPMENT** be pleased to state:

- (a) the details of the Shyama Prasad Mukherji Rurban Mission (SPMRM) under implementation in West Bengal;
- (b) the funds sanctioned and utilised for the Mission in West Bengal so far; and
- (c) the nature of works and projects to be undertaken in West Bengal under the Mission?

(a) : Under Shyama Prasad Mukherji Rurban Mission (SPMRM), the state of West Bengal has been allocated 7 clusters under Phase I and 3 clusters each under Phase II and III. The state has not submitted cluster list for Phase-III.

Under Phase-I of the SPMRM the State has submitted the Integrated Cluster Action Plan (ICAPs) for 7 clusters and the details of Investment, Convergence and CGF approved is as follows.

The works on ground under Phase-I of the SPMRM has not started in the State because the Detail Project Reports (DPRs) of the proposed works approved in ICAPs are yet to be submitted by the State.

Under Phase-II of the SPMRM, the State has not submitted the Integrated Cluster Action Plans (ICAPs) of the approved clusters to the Ministry so far.

Under Phase-III, the State has been allocated 3 clusters by the Ministry but the approved cluster list by State Level Empowered Committee (SLEC) is still awaited from the state.

(b) : Under Phase I, the total fund released to the State of West Bengal is Rs 2.45cr towards administrative fund and Rs. 35.10cr towards 1st instalment of CGF.

(c): The State of West Bengal has proposed an investment of Rs. 659.85 cr for provision of 24X7 Piped water supply, Sanitation, Solid Liquid Waste Management, Access to Village Street with Drains, Street Lights, Public Transport, LPG connection, Digital Literacy, Skill Development Training linked with Economic Activities, Agri Services and Processing, Health, up-gradation of Primary and Secondary education and development of social infrastructure in all the 7 clusters under Phase –I of the SPMRM.
