REDUCTION OF AIR FARE FOR HAJ PILGRIMS

2861. SHRIMATI CHHAYA VERMA: SHRI VISHAMBHAR PRASAD NISHAD: CH. SUKHRAM SINGH YADAV:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether it is a fact that the air fare of Haj pilgrims proceeding on Haj yatra this year has been reduced upto 45 per cent;
- (b) if so, whether more air fare was being charged by increasing air fare from Haj pilgrims in name of Haj subsidy for last several years;
- (c) the names of airlines which have started operations this year for Haj pilgrims and whether more airlines are desirous to take Haj pilgrims and whether due to coming of more airlines Haj yatra for Haj pilgrims is likely to be possible at lower fares; and
- (d) if so, details thereof?

ANSWER

MINISTER OF MINORITY AFFAIRS (SHRI MUKHTAR ABBAS NAQVI)

(a) and (b) Air travel arrangements for the pilgrims going through Haj Committee of India (HCoI), a statutory organization under Ministry of Minority Affairs are made through the Ministry of Civil Aviation, which is the nodal Ministry in this regard. Air travel cost depends on the lowest price discovered for each embarkation point through competitive bidding in which several airlines of Saudi Arabia and India participate. As per the bilateral agreement with the Kingdom of Saudi Arabia, bids were invited from the scheduled airlines of India and Saudi Arabia for Haj 2018 air charter operations from 20 Embarkation Points (EPs). Based on the L1 rates, Air India (07 EPs), Saudi Airlines (07 EPs) and Flynas (06 EPs) have been selected to operate for air transportation of pilgrims for Haj 2018. A comparison of the lowest airfare arrived through competitive bidding for Haj 2014 and Haj 2018 (excluding taxes, airport charges and applicable Haj subsidy) reveals that rates quoted by the airlines have substantially come down. The comparative list of lowest airfare quoted by airlines in US dollars for Haj 2014 and 2018 is in the annexure.

(c) & (d) For Haj 2018 air charter operations, Air India, Saudi Airlines and Flynas of Saudi Arabia has been selected for Haj charter operations. As per the bilateral agreement with Kingdom of Saudi Arabia, bids are invited from all the scheduled airlines of India and Saudi Arabia and the bids are awarded to the airlines on the basis of the lowest rates arrived through competitive bidding. It is the endeavor of the Government to bring the airfares down through competitive bidding within the framework of the annual bilateral agreement with Kingdom of Saudi Arabia.
