- (b) the details of the proposals out of the above which have been approved and the subject for which those are related;
- (c) the details of the proposals which are pending with the Central Government for their approval as on date; and
- (d) whether it is also a fact that as a result of pendency of proposals, there is likelihood of delay in achieving the purpose of the proposals and cost-overrun thereof?

# THE MINISTER OF STATE (INDEPENDENT CHARGE) FOR YOUTH AFFAIRS & SPORTS {COL. RAJYAVARDHAN RATHORE (RETD.)}

- (a) 14 proposals were received under the sports promotional schemes of this Ministry from Odisha during the last three years for a total estimated value of Rs.131.26 crore. No specific proposals was received under youth promotional schemes from Odisha during the last three years.
- (b) Details of the proposals out of the above which have been approved and the subject for which those are related are given at Annexure I.
- (c) The details of proposals which are not approved as on date is given at Annexure II.
- (d) The proposals are considered based on technical feasibility, budget constraints and keeping in mind distribution of available resource among various States/UTs. Hence, approving all the projects received in this Ministry from various States/UTs / other entities are not feasible. In addition, sports is a State subject and, therefore, it is primarily the responsibility of the State Government to promote the subject in the respective States of the country. The Central Government complements/supplements the efforts of the State Governments.
