EXTRADITION TREATIES WITH FOREIGN COUNTRIES

3060. SARDAR BALWINDER SINGH BHUNDER:

Will the Minister of EXTERNAL AFFAIRS be pleased to state:

- (a) the details of extradition laws/treaties with USA, UK, UAE, Hong Kong and European countries;
- (b) how many persons have been extradited to India, since 2014 from above countries; and
- (c) the details of fugitives which are yet to be extradited since 2014 with details of economic offences against them?

ANSWER

THE MINISTER OF STATE IN THE MINISTRY OF EXTERNAL AFFAIRS [GEN. (DR) V. K. SINGH (RETD)]

- (a) As of now, India has signed extradition treaties with 48 countries including USA, UAE, Hong Kong and the following European countries namely Belgium, Bulgaria, France, Germany, Lithuania, Netherlands, Poland, Portugal, Spain, Switzerland and UK. In addition, India has entered into extradition arrangement with three other European countries namely Croatia, Italy and Sweden.
- (b) Since 2014, 04 fugitives have been extradited to India from the above named countries.
- (c) The details of the fugitives who are yet to be extradited since 2014 in cases related to economic offence from the above countries are as under:
