- (a)to(d) The Ministry of Housing and Urban Affairs facilitates and assists States/Union Territories (UTs), through its flagship Missions/schemes viz. Swachh Bharat Mission (SBM), Pradhan Mantri Awas Yojana (Urban)(PMAY-U) and Deendayal Antyodaya Yojana-National Urban Livelihoods Mission(DAY-NULM) to improve urban infrastructure including amenities for the urban poor, address the livelihood concerns of urban poor and enhance the quality of life in cities and towns covered under these Missions/schemes. The Central Government approves the State Plans and provides the Central Assistance to the States. The projects are designed, approved and executed by the States/UTs and the Cities. The details of schemes & funds provided and the achievements under these Missions are given in the Annexure.

ANNEXURE REFERRED TO IN REPLY TO PART (C) & (D) OF RAJYA SABHA UNSTARRED QUESTION NO 3080 REGARDING 'AMENITIES TO URBAN POOR' FOR ANSWER ON 22 MARCH, 2018.

SWACHH BHARAT MISSION

A Centrally Sponsored Scheme i.e. Swachh Bharat Mission(Urban) [SBM-U] was launched on 2nd October, 2014. The objectives of the Mission is to address both elimination of open defecation and Solid Waste Management in all 4041 Urban Local Bodies (ULBs) of the country by 2nd October, 2019. The details of SBM(U) scheme are as follows:-

1. Elimination of open defecation
2. Eradication of Manual Scavenging
3. Modern and Scientific Municipal Solid Waste Management
4. To effect behavioural change regarding healthy sanitation practices
5. Generate awareness about sanitation and its linkage with public health.
6. Capacity augmentation of urban Local Bodies (ULBs) to create an enabling environment for private sector participation in Capex (capital expenditure) and Opex (operational and maintenance).

Deendayal Antyodaya Yojana-National Urban Livelihoods Mission

Deendayal Antyodaya Yojana-National Urban Livelihoods Mission (DAY-NULM) address the livelihood concerns of urban poor with effect from September, 2013 on all India basis through respective State/UT Governments. The DAY-NULM focuses on organizing urban poor in Self-Help Groups (SHGs), creating opportunities for skill development leading to market-based employment and helping them to set up self-employment ventures by ensuring easy access to credit. The Mission is aimed at providing shelter to the urban homeless in a phased manner. In addition, the Mission would also address livelihood concerns of the urban street vendors.

- Fund released under DAY-NULM so far since its inception is Rs. 1516.43 crore.
