- (a) Whether sanctioning amount of grants to Residential School of Blind and Handicapped Teaching and Charitable Samiti, Amakherava, Manendragarh and School of Akanksha Lions School Farm Mentally Handicap, Avanti Vihar, Raipur in Chhattisgarh is required; and
- (b) Whether sanctioning the amount of grants for Hearing Impaired School, Sarguja, Gyanodya Association, Vishrampur and Vocational Training Centre and for community based Rehabilitation programme is also required?

(a) & (b) The Department of Empowerment of Persons with Disabilities (Divyangjan) supplements the efforts of voluntary organisations in rehabilitation of persons with disabilities through the Central Sector Deendayal Disabled Rehabilitation Scheme (DDRS). Financial assistance is provided to Non-Government Organizations for providing various services to persons with disabilities including special schools, vocational training centres and community based rehabilitation programme. The details of grants-in-aid released to the said NGOs during the last two years and the current year under DDRS are annexed.
