Pollution in major cities and rivers

3398. DR. SATYANARAYAN JATIYA:

Will the Minister of ENVIRONMENT, FOREST AND CLIAMATE CHANGEbe pleased to state:

- (a) the names of the five major cities which have recorded the highest level of water and air pollution in the country during last three years and the changes and additions noticed at present in those cities;
- (b) the comparative details regarding the pollution in five major rivers along with the places where highest level of water pollution has been recorded during the said period; and
- (c) the results of the measures taken to control pollution at these places during the last three years?

(a) & (b) Five cities with highest concentrations of SO₂, NO₂ and PM10 during 2014-2016are at Annexure I.

Water quality monitored under National Water Quality Monitoring Programme, is not city centric. The Central Pollution Control Board has identified 302 polluted river stretches in 275 rivers, which is at Annexure II. The cities identified along the five most polluted rivers stretches are Manivilundhan, Thalaivasal and Thiyaganur along river Vasista; Meerut, Hapur, Gulaothi and Bulandshahr along river Kalinadi (East); Kanchigam and Vapi along river Daman Ganga; Kala Amb and Ogli along River Markanda; Bhagwanpuraand Kishangarh along river Sukhana.

(c) The result of measures taken for abatement of air and water pollution is reduction in their levels as against business as is usual scenario.
