MARKET SHARE OF AYURVEDIC DIABETES MEDICINES

4002. SHRI MAHESH PODDAR:

Will the Minister of **AYURVEDA, YOGA & NATUROPATHY, UNANI, SIDDHA AND HOMOEOPATHY** be pleased to state:

- (a) the share of Ayurvedic medicines among the medicines available in the market for the treatment of diabetes; and
- (b) the number of Ayurvedic companies having the licences to manufacture and market the medicines for the treatment of diabetes and the details thereof?

(a): The statistical information about the total contribution of Ayurvedic healthcare and medicine manufacturing to the GDP is not available except percentage share of ayurvedic products in the GDP. GDP statement of pharmaceuticals, medicinal chemicals and botanical products available in the market including medicines for the treatment of diabetes along with percentage share of ayurvedic products to the GDP for the last five years is given at **Annexure.**

(b): There are 7439 licensed Ayurvedic drug manufacturing pharmacies in India. As per information received from states such as in Assam 9 companies are manufacturing 19 medicines, Odisha 7 companies are manufacturing 7 medicines, in Andhra Pradesh out of 301 companies 36 companies manufacturing 45 medicines, in Kerala out of 650 companies, 300 companies are manufacturing medicines, in Gujarat 56 companies are manufacturing 85 medicines, in Punjab 6 companies are manufacturing 6 medicines, in Puducherry 2 companies are manufacturing 4 medicines, in Chennai 40 companies manufacturing medicines and in Uttarakhand 35 companies are manufacturing medicines for treatment of diabetes.
