PAYMENT OF RENT TO OWNERS OF PRIVATE GODOWNS

1202. MAHANT SHAMBHU-PRASADJI TUNDIYA:

Will the Minister of CONSUMER AFFAIRS, FOOD AND PUBLIC DISTRIBUTION be pleased to state:

- (a) whether Government has any data about rent paid to the private godown owners to store the foodgrains purchased by Government;
- (b) the details of Government and private godowns in the country, State-wise;
- (c) the details of storage capacity for both types of godowns;
- (d) the details of rent paid to private godown owners; and
- (e) the details regarding duration of time in a year during which godowns remain empty/underutilised, private and Government, godown-wise?

ANSWER

MINISTER OF STATE FOR CONSUMER AFFAIRS, FOOD & PUBLIC DISTRIBUTION (SHRI C. R. CHAUDHARY)

- (a): Yes, Sir.
- (b): As on 30.06.2018, a total of 2090 godowns are available with Food Corporation of India (FCI) for storage of central pool stock comprising 1516 Government godowns and 574 private godowns. The State-wise details are at **Annexure.**
- (c): As on 30.06.2018, the storage capacity available with FCI for storage of central pool stock is 381.06 Lakh Metric Tonnes (LMT) comprising 264.58 LMT in Government godowns and 116.48 LMT in private godowns. In addition, 474.92 LMT is available with the State Governments for storing central pool stocks.
- (d): The rent paid to private godown owners by FCI was Rs 834.11 Cr in the year 2017-18.
- (e): FCI has either owned or hired godowns and its utilization varies from month to month depending on the level of procurement. Usually, FCI does not have any capacity which is unutilized or empty except godowns which are under repair, renovation or declared defunct. However, in case private godowns are underutilised or empty, the same are immediately dehired. FCI owned godowns are sometimes not utilized to optimum level due to various reasons/circumstances which are given below:

- (i) The utilization of hired capacities is given priority as FCI has to pay fixed rentals for hired godowns irrespective of utilization.
- (ii) Some of the FCI owned godowns are under zero physical verification and stocks are completely issued to check the quantity of foodgrains.
- (iii)In order to control high cost of handling in FCI owned depots (due to departmental labour), low cost hired depots are preferred.
- (iv)FCI owned silos constructed in 1960 and 1970 have become inoperative and are not utilized. These include 21,000 MT at Mayapuri (Delhi), 72,000 MT at Chandari (Uttar Pradesh), 32,000 MT at Gaya (Bihar) and 20,000 MT at Khurja (Uttar Pradesh). Some depots have come within city limits and cannot be utilized effectively due to vehicular restriction etc.
- (v) Repair and maintenance of own depots.
