Functioning of Standing Committee of NBW

*145. SHRI RITABRATA BANERJEE:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the total duration for which Standing Committee of the National Board for Wildlife (NBW) has met in the last three years, and the details of tasks undertaken therein;
- (b) the list of proposals seeking approvals, received during last three years by Standing Committee of the NBW, and their clearances/rejections status;
- (c) the number of proposals seeking approvals received by the Standing Committee during the period 2004-2014 and the status of corresponding clearances/ rejections; and
- (d) the details of steps taken by Government to ensure that wildlife and ecology are protected?

ANSWER

(a), (b) (c) and (d) A Statement is laid on the Table of the House.

STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (d) OF THE RAJYA SABHA STARRED QUESTION NO *145 REGARDING 'FUNCTIONING OF STANDING COMMITTEE OF NBW' BY SHRI RITABRATA BANERJEE DUE FOR REPLY ON 24.12.2018.

- (a) The Standing Committee of National Board for Wildlife has met 19 times in the last three years, considered 720 proposals, and recommended 716 proposals of developmental projects falling inside or within 10 km from the boundary of protected areas along with mitigation measures on case to case basis received from the State Government and with the recommendations of the State Board for Wildlife.
- (b) List of proposals considered and recommended by the Standing Committee of National Board for Wildlife during the last three years is placed at **ANNEXURE-I**.
- (c) During the period 2004-2014, the Standing Committee of National Board for Wildlife received 486 proposals, out of which 435 proposals were recommended while 29 proposals were rejected.
- (d) The Standing Committee considered the proposals seeking its recommendation on a case to case basis. The views of expert members are duly considered before taking any decision, site inspection visits are also undertaken by domain experts to see the impact of projects / activity on the concerned protected area. The Standing Committee recommends proposals based on the facts and records submitted by the State Board for Wildlife as well as the mitigation measures suggested by the Chief Wildlife Warden of the concerned State / UT. In addition, the Ministry also provides financial assistance under the Centrally Sponsored Scheme –Integrated Development of Wildlife Habitats', which, *inter-alia*, caters to protection measures for ensuring better habitats for wildlife and overall wildlife conservation in all the Protected Areas of the country.
