**SETTING UP OF SMART BIO-TOILET BY GSCL**

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:

- (a) whether Guwahati Smart City Ltd. (GSCL) has launched a project for setting up of smart bio-toilet at major locations of the city under the Smart Cities Mission; and
- (b) if so, the details thereof along with the locations identified, estimated cost of the project and whether the project has been completed?

- (a)&(b): Yes, Sir. Thirty units of smart bio-toilets have been taken up under Guwahati Smart Cities Mission. Location of these smart bio-toilets is at Annexure. The estimated project cost is Rs. 9.53 crores (inclusive of one year of Operation and Maintenance). The project is under implementation. Presently, 17 of 30 units have been commissioned.
