### **Forest clearance for Government Projects**

### 1505. SHRI HARSHVARDHAN SINGH DUNGARPUR:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to State:

- (a) the details of forest land cleared for various Government projects during the years 2013 to 2017;
- (b) the details of cases pending before Government or received during the said period for environment clearances; and
- (c) the steps taken/proposed to be taken by Government in this regard?

## **ANSWER**

### MINISTER OF STATE IN THE MINISTRY OF ENVIRONMENT, FOREST AND CLIMATE CHANGE (DR. MAHESH SHARMA)

- (a) States/UTs-wise list of forest land diverted for non-forestry purpose for various Government projects during the years 2013 to 2017 is annexed as Annexure-A.
- (b) Currently 28 proposals pertaining to the period 2013 to 2017 are being appraised for Environment clearances by the Ministry of Environment Forest and Climate Change under Environment Impact Assessment Notification, 2006 and its amendment from time to time.
- (c) The Ministry has taken several steps to expedite the process of environmental and forest clearances which inter-alia include introduction of Single window clearance portal-PARIVESH(Pro-Active and Responsive facilitation by Interactive, Virtuous and Environmental Single window Hub), an online system of processing of environmental clearances, forest clearances, wildlife clearances, introduction of Short Message Service (SMS) functionality for Project proponent, auto alert system; separate module to track the progress of recommended projects, delegation of powers to Regional Empowered Committee (REC) to finally dispose of the proposals.
