1596. SHRI PARTAP SINGH BAJWA:

Will the Minister of YOUTH AFFAIRS AND SPORTS be pleased to state:

(a) the total revenue earned from National Sports Stadia across the country in the financial year 2017-18;

- (b) the sources of revenue earned, stadium-wise;
- (c) details of office, commercial and hospitality spaces, stadium-wise;

(d) whether the Ministry has taken any concrete steps to generate revenue through these infrastructures;

- (e) if so, the details and results thereof; and
- (f) if not, the reasons therefor?

ANSWER

THE MINISTER OF STATE (INDEPENDENT CHARGE) FOR YOUTH AFFAIRS AND SPORTS {COL. RAJYAVARDHAN RATHORE (RETD.)}

(a) & (b): Sports Authority of India (SAI), an autonomous body under Ministry of Youth Affairs and Sports is managing only five stadia in Delhi. Prime objective of SAI is to make the facilities available for training of international, national and state level player and those who may join under Come and Play Scheme. Stadia/space are rented out/ leased only if it does not disturb athletes training priorities. Stadia/Head-wise revenue earned during the financial year 2017-18 is at Annexure-I.

(c) Details of allotment of spaces, which were available for commercial use to Government Departments at SAI Stadia Delhi are at Annexure-II.

(d) to (f): To optimize the utilization of sports facilities available in SAI Stadia in Delhi and to generate revenue through utilization of underutilized or unutilized space available in SAI Stadia in Delhi, SAI has rented out space in stadia to various Government Departments like Ministry of Home Affairs & Income Tax etc. Apart from this facilities of stadia are also made available to private agencies for non-sport activities without compromising sports related activities.
