(a) to (c): The State-wise details of production and procurement made by Government Agencies at Minimum Support Price (MSP) as well as percentage procurement of wheat, paddy in terms of rice and coarse grains during the Rabi Marketing Season (RMS) 2018-19 and ongoing Kharif Marketing Season (KMS) 2018-19 as on 26.12.2018 are at Annexure-I and II. The State-wise details of pulses procured as on 21.12.2018 at Minimum Support Price (MSP) under Price Support Scheme (PSS) as reported by Department of Agriculture, Cooperation and Farmers Welfare is at Annexure-III. The details of Minimum Support Price(MSP) announced by the Government of India for procurement of foodgrains are at Annexure-IV.
