SETTING UP OF FOOD PARKS

696. SHRI SYED NASIR HUSSAIN:

Will the Minister of FOOD PROCESSING INDUSTRIES be pleased to state:

- (a) whether Government has any proposal to set up food parks in the country to create modern infrastructure for food processing, if so, the details thereof;
- (b) the details of parks identified/established/approved over the last five years, along with financial assistance or funds provided to such parks;
- (c) the procedure to select such projects; and
- (d) whether any State Government has requested the Central Government to set up food parks, if so, the details thereof?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES

(SADHVI NIRANJAN JYOTI)

- (a): Ministry of Food Processing Industries is presently not implementing Food Parks scheme. However, Ministry of Food Processing Industries has been implementing Mega Food Park Scheme (MFPS) to create modern infrastructure for food processing. Government has sanctioned a total of 42 slots for setting up of Mega Food Park Projects in the country. For two vacant slots, Ministry has issued fresh Expression of Interest (EoI) on 23.12.2018 to seek proposals. As of now, out of 40 approved Mega Food Parks in the country, 14 Mega Food Parks are operational.
- (b): At present, Ministry of Food Processing Industries is assisting 25 Mega Food Parks approved during last five years in the country under the Mega Food Park scheme. Out of these, 23 Mega Food Parks have been accorded final approval, 2 Mega Food Parks accorded in-principal approval by the Ministry during the period. The details of these 25 Mega Food Parks approved by the Ministry during last five years under the Mega Food Park Scheme along with the amount of grant released to these parks are at **Annexure-I.**
- (c): The proposals under scheme for Mega Food Park for setting up of Mega Food Parks in the country are invited from time to time through EoI. Selection is done as per the Scheme guidelines, based on the merit, through a stringent appraisal process as per predefined criteria. Proposal received in response to EoI are evaluated by Programme Management Agencies (PMAs). Proposals having ownership and possession of suitable land with Change in Land Use (CLU) for the project are given preference. The applicants are invited to make a presentation of their proposals before the Technical Committee headed by the Additional / Joint Secretary which makes its recommendations to the Inter-Ministerial Approval Committee. The Inter-Ministerial Approval Committee, headed by Hon'ble Minister of Food Processing Industries selects the projects and grant In-Principle Approval and Final Approval as per the provisions of scheme guidelines.
- (d): Ministry of Food Processing Industries has accorded approval to 08 Mega Food Park projects of the State Government implementing agencies so far under Mega Food Park scheme. Details of these Mega Food Parks are at **Annexure-II.**
