### BENEFIT TO WOMEN FARMERS UNDER PMFBY AND PM-KISAN SCHEMES

1445. SHRI PARTAP SINGH BAJWA:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) the number of women farmer applications under Pradhan Mantri Fasal Bima Yojana (PMFBY) in the years 2019-2020, 2020-2021 and 2021-2022, State-wise;
- (b) the number of women farmer beneficiaries under PMFBY in the years 2019-2020, 2020-2021 and 2021-2022, State-wise;
- (c) the number of women farmers enrolled under Pradhan Mantri Kisan Samman Nidhi (PMKISAN) in the years 2019-2020, 2020-2021 and 2021-2022, State-wise; and
- (d) the total funds transferred to women farmers under PM-KISAN in the years 2019-2020, 2020-2021 and 2021-2022, State-wise?

#### **ANSWER**

# MINISTER OF AGRICULTURE AND FARMERS WELFARE (SHRI NARENDRA SINGH TOMAR)

- (a) & (b): The Pradhan Mantri Fasal Bima Yojana (PMFBY) was introduced in the country from 2016-17, but collection of granular data of coverage including coverage of small and marginal famers under the scheme on National Crop Insurance Portal (NCIP) was started from 2018-19. The admissible claims to eligible farmers including women farmers are paid by concerned insurance companies directly in farmer's bank account. State-wise details of women farmers' applications who got premium subsidy benefit under the scheme during 2019-20 to 2021-22 is at **Annexure-I.**
- (c) & (d): Year-wise details of women beneficiaries registered and the financial benefit provided to them under PM-KISAN for the years 2019-20, 2020-21 and 2021-22 are given in **Annexure-II** and **Annexure-III** respectively.
