LACK OF STORAGE FACILITIES FOR AGRICULTURAL PRODUCES

653 SHRI T.G. VENKATESH: SMT. KANTA KARDAM:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to state:

- (a) whether Government has taken note that farmers are facing innumerable difficulties for want of proper storage facilities to store their agricultural produces;
- (b) if so, details thereof and the measures taken thereon;
- (c) whether any State Government has made any proposals for increase of storage facilities in their States to stock the agriculture produce, if so, details thereof;
- (d) whether Government proposes to give any interest-free loans for construction of sufficient godowns for the purpose of storing agricultural produce; and
- (e) the measures being taken by Government for increasing the storage facilities in country in view of demands of farmers, if so, details thereof, State-wise?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE (SHRI NARENDRA SINGH TOMAR)

(a) & (b): The Government is implementing Agricultural Marketing Infrastructure (AMI), a sub-scheme of Integrated Scheme for Agricultural Marketing (ISAM) under which assistance is provided for construction/ renovation of godowns/ warehouses in the rural areas in the States to enhance the storage capacity for agriculture produce.

Since 01.04.2001 and up to 30.09.2021, a total of 40,985 storage infrastructure projects (Godowns) with capacity of 708.67 Lakh MT have been assisted in the country benefitting a number of Agri-preneurs including farmers.

Further, Department of Food and Public Distribution, Government of India, deals with creation of storage facilities for foodgrains procured under the Public Distribution System. Depending on requirement in specific areas and for modernization of the storage facilities, the Government implements Private Entrepreneurs Guarantee (PEG) scheme & Central Sector Scheme (erstwhile Plan Scheme). Under PEG Scheme, 144.34 Lakh MT capacity has been created. Under Central Sector Scheme, a capacity of 2.66 Lakh MT has been created.

(c): The information received from State Governments is at Annexure-I.

Government has approved a new central sector scheme for Financial Facility under (d): Agriculture Infrastructure Fund (AIF) of Rs. 1,00,000 Crore to provide a medium-long term loan facility for investment in viable projects for post-harvest market infrastructure including warehousing facility and community farming assets through interest subvention and financial support. AIF provides financial support in terms of Interest Subvention and Credit Guarantee on loans for post harvest management projects like Warehouses, Cold Chains, Silos etc. and building community farming asset projects. Under the scheme, loans are provided by banks and financial institutions to Primary Agricultural Credit Societies (PACS), Marketing Cooperative Societies, Farmer Producers Organizations (FPOs), Self Help Group (SHG), Farmers, Joint Liability Groups (JLG), Multipurpose Cooperative Societies, Agrientrepreneurs, Startups and Central/State agency or Local Body sponsored Public Private Partnership Project. All loans under this financing facility have interest subvention of 3% per annum up to a limit of Rs. 2 crore. This subvention is available for a maximum period of 7 years. Further, credit guarantee coverage is available for eligible borrowers from this financing facility under Credit Guarantee Fund Trust for Micro and Small Enterprises (CGTMSE) scheme for a loan up to Rs. 2 crore. So far, Rs 4143.6 Crore have been sanctioned for 4491 warehouse projects.

(e): Answered in (a) to (d) above, to increase the storage facilities in country, the Government is providing assistance through AMI sub-scheme of ISAM, the details of which is annexed at **Annexure – II**. As per the information received from Department of Food and Public Distribution, Government of India, the details of storage capacity created under PEG scheme is annexed at **Annexure –III**.

- I. As informed by Government of Tamil Nadu, State Government has taken initiatives to construct 11 Nos. of godowns in Tiruvarur district with total capacity of 16000 MT; 4 Nos: 250 MT capacity godown in Tiruppur, Pudukottai, Erode, and Namakkal District; 10 Nos of 500 MT capacity Storage Godowns in Villupuram, Tiruvannamalai (2 Nos.), Vellore, Kallakurichi, Erode, Thanjavur, Nagapattinam, Tiruvarur and Cuddalore District; and 2 Nos. of Godowns with the capacity of 1500 MT at Thälavadi Régulated Market in Erode District.
- II. The Government of Telangana informed that during the years 2015 to 2020, the State Government has constructed 457 number of scientific godowns with storage capacity of 17.35 LMTs @ Rs. 1024.50 Crores with the assistance of NABARD.
- III. As informed by Government of Andhra Pradesh, it has initiated the process of construction of 4,277 rural godowns farm gate level across the state with a total capacity of 23.72 Lakh MT.
- IV. The Govt. of Madhya Pradesh has informed that the State Government has enacted Madhya Pradesh Warehousing and Logistics Policy 2012 which was applicable till 2016. As per the said policy, investors in Warehousing were offered by the State Government 15% contribution in share capital and 5% contribution in interest for 7 years. Here, it is pertinent to mention that the steel silo of capacity 4.5 Lakh MT is constructed in state under PP mode for safe storage of agriculture produce. Moreover 250 Lakh MT capacity is available in Government and private sector together.
- V. The Government of Rajasthan has informed that Rajasthan Agro-processing, Agrobusiness and Agri-export Promotion scheme 2019 is under implementation since 12-12-2019 and warehouse and cold storage for agri produce are eligible activities for capital and interest subsidy.
