However, now after the issuance of the Tribunal Reforms Act, 2021 and framing of Rules there-under, the process of making selection of Members of CAT has begun with the constitution

	of a high-powered Search-cum-Selection Committee with nomination of a sitting Judge of the Supreme Court as its Chairman, and other members.
	Further, the reason for the pendency of the cases are as follows:
	(i) Some cases are adjourned sine-die due to the reason that the matters have been sub-judice before the Hon'ble Supreme Court/ High Courts.
	(ii) Some cases have been restored/ remanded back by the Hon'ble Supreme Court and Hon'ble High Courts after long time and hence, these cases retain their original institution date in the Tribunal.
	(iii) Some cases were initially dismissed in default and later on restored.
	(iv) In some cases, the Ld. Counsels seek time for

		filing reply/ rejoinder.
		(v) Moreover, during the COVID-19 pandemic period, only those cases were listed for hearing where both the parties have agreed for hearing through video conferencing.
		(f) The total pending 74,567 cases as at the end of year 2021 includes 18,092 cases that have been transferred from the Hon'ble High Court of Jammu & Kashmir to CAT in the years 2020 and 2021.
		It may be pertinent to mention that since the inception of CAT, 8,70,409 cases have been instituted and out of these, 7,95,842 cases have been disposed. Overall disposal percentage of cases in CAT is 91.43%. However, all efforts are being made by the CAT for disposal of the old cases on priority basis.
