'SPMRM IN PUNJAB'**

(a) Under Shyama Prasad Mukherji Rurban Mission, the State of Punjab has been allocated eight(08) clusters. The details of the clusters are annexed at Annexure 1.

(b) As on 19th July, 2022, the number of total works approved in the Detailed Project Reports (DPRs) of the Rurban clusters in the State is 496 for which an amount of Rs. 639.83 crore has been approved as convergence investment. The cluster-wise details are annexed at Annexure 2.

(c) & (d) Geo-tagging of resources under the scheme avoid duplication and double reporting of works, measures progress of work on a timeline, helps mapping of resources with location by latitude and longitude which can be used as a planning tool. No audit, specifically, has been carried out on geo-tagging. However, financial audit of the scheme is conducted every year by Chartered Accountant. Audit of the State Nodal Account has been carried out by the Auditor of Accountant General, Punjab and reports corresponding to the period 2015-16 to 2020-21 have already been submitted to the Ministry.
