“COMPENSATION TO FAMILIES OF COVID-19 VICTIMS”

1871. SMT. JEBI MATHER HISHAM:

Will the Minister of **HEALTH & FAMILY WELFARE** be pleased to state:

- (a) the number of deaths that have been reported due to COVID-19 pandemic till date, State-wise;
- (b) the number of aggrieved families who have been provided compensation and how much amount has been disbursed; and
- (c) whether Government has devised any special scheme to tackle post- COVID-19 health disorders?

ANSWER

(a) to (c): As reported by States/UTs, as on 28th July 2022 a total of 5,26,211 deaths due to COVID-19 have been reported in the country. State/UT wise details of number of deaths reported due to COVID-19 is at **Annexure**.

As per information received from various State Governments/UT Administration, as on 27th May 2022, total 7,91,353 claims have been settled/payment released as ex-gratia from State Disaster Response Fund (SDRF) to next of kin of the persons who died due to COVID-19. The ex-gratia is paid by the States as per extended criteria for giving ex-gratia in case of deaths due to COVID-19, by Hon'ble Supreme Court.

Ministry of Health & FW on 21st October 2021 has issued a National Comprehensive Guidelines for Management of Post-Covid Sequelae. The guidelines provide detailed guidance on common presenting signs and symptoms, system wise complications, investigations required, other differential diagnosis to be considered and clinical treatment.

Ministry of Health & Family Welfare in collaboration with AIIMS, Delhi (as Center of Excellence) and other State level Centers of Excellence and in association with Indian Medical Association has organized a series of webinars for healthcare professionals engaged in public and private health facilities at State and District levels on COVID-19 clinical management related issues including management of post-COVID complications.
