# STATEMENT REFERRED TO IN REPLY TO PARTS (a) TO (c) OF THE RAJYA SABHA STARRED QUESTION NO. 160 ANSWERED ON 21.12.2022 ASKED BY SHRI PABITRA MARGHERITA REGARDING **MONETARY AWARD FOR GOOD SAMARITANS**

(a) The Ministry of Road Transport & Highways has launched a Scheme in October, 2021 for grant of Award to the Good Samaritan who has saved life of a victim of an accident involving a motor vehicle by administering immediate assistance and rushing the victim to Hospital/Trauma Care Centre within the Golden Hour of the accident to provide medical treatment. The scheme is implemented through States/UTs.

The objective of the Scheme is to motivate the general public to help the road accident victims in emergency situation, inspire and motivate others to save innocent lives. The scheme provides each Good Samaritan with cash award of Rs.5000/- and a certificate of appreciation per incident, subject to maximum 5 awards to an individual in a year.

Besides award in each case, the scheme also provides 10 National Level Awards of Rs.1,00,000/- each for the most worthy Good Samaritans from all those who have been awarded during the whole year.

The procedure including manner of providing financial assistance has been detailed in the Scheme Guidelines and the same is available in public domain on the Ministry's website - <u>https://morth.nic.in/schemes-projects</u>.

(b) & (c) It is a new road safety initiative by the Ministry of Road Transport & Highways. Till now, 19 States /UTs have been sanctioned an initial grant of Rs.5 lakhs each for implementation of the Good Samaritan Scheme. Out of this, initial grant has been released to 12 States. As per the information received from these 12 States, total number of Good Samaritan awarded till now are 80. State-wise, financial year-wise list of number of Samaritans awarded with cash award of Rs.5000/- and a certificate of appreciation per incident, is given at **Annexure - I**.
