- (b) the number of suppliers who have actively participated in trade activities on the Portal out of the total registered; and
- (c) the details about the total number of suppliers who have participated in the Portal from Telangana, in absolute figures as well as comparative to the rest of the country?

(a) There are 11,13,998 new suppliers who have registered themselves in the Government e-Marketplace (GeM) to enable them to sell their products directly to various Government departments and organizations. The state wise and year wise breakup since last three years is as under:

(b) There is no definition of an active supplier on GeM. Registered suppliers decide to participate in any bid depending on their interest, availability of products and other factors. All the registered sellers have equal opportunity to participate in the marketplace and bids. Successful award of an order is contingent on the requirement given by the buyer and the ability of seller to meet the requirement by offering the most competitive price.

(c) As on 05-12-2022, total **49,004** sellers have participated in the Portal from Telangana, which is ~ 4.6 % in comparison to the rest of country figure .
