#### Fines imposed on polluters

1008. SHRI DEEPENDER SINGH HOODA:

Will the Minister of ENVIRONMENT, FOREST AND CLIMATE CHANGE be pleased to state:

- (a) the details of companies that have been imposed fines both by the NGT and under the provisions of the NCAP for contributing to air pollution in the Delhi NCR area;
- (b) the details of amount collected by Government as fines and penalties along with the details of such polluters;
- (c) the details of vehicular fines imposed and dues collected in the years 2020, 2021 and 2022;
- (d) whether fines have been imposed on farmers in Delhi, Haryana, Uttar Pradesh and Punjab burning paddy straw; and
- (e) if so, the complete details thereof?

### **ANSWER**

#### (a), (b), (c), (d)& (e):

CPCB in compliance to the directions of Hon'ble NGT has imposed Environmental Compensation (EC) against those accountable for setting up and maintaining pollution control systems in industries or facilities.

Details of Environmental Compensation imposed on various industries are enclosed as **Annexure-I**.

Details of vehicular fines imposed by State Government and Govt. of National Capital Territory of Delhi are enclosed at **Annexure-II**. Government of Punjab, Haryana and Uttar Pradesh have imposed environmental compensation on defaulting farmers in respect of paddy stubble burning. Details of are placed at **Annexure-III**.
