FACE AUTHENTICATION IN LIFE CERTIFICATE

Will the **PRIME MINISTER** be pleased to state:

- (a) whether Government has introduced face authentication technology for the pensioners to submit 'Life Certificate';
- (b) if so, the details thereof;
- (c) the number of pensioners who are required to submit a Life Certificate, State-wise;
- (d) the number of pensioners who have used face authentication technology since its commencement, State-wise including Gujarat;
- (e) whether it is mandatory for pensioners to use face authentication technology for the life certificate, if so, the details thereof; and
- (f) Whether the pensioner will be denied benefits of pension if he refuses to submit Life Certificate through Jeevan Pramaan App by using the face authentication facility, if so, details thereof?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF PERSONNEL, PUBLIC GRIEVANCES AND PENSIONS AND MINISTER OF STATE IN THE PRIME MINISTER'S OFFICE (DR. JITENDRA SINGH)

- (a) to (d): Yes, sir. The Government launched Face Authentication Technology in November 2021 for submission of Life Certificate by Central Govt. pensioners. All Central Government pensioners are required to submit life certificate every year for uninterrupted disbursement of their pension. Till 8th December, 2022, 3,71,364 Central Government pensioners have submitted life certificate using face authentication technology since its launch. The State wise details in this regard are at Annexure.
- (e): No, sir.
- (f): No, sir. Pensioners can use any of the prescribed modes, including Face Authentication technology, to submit Life Certificate.
