(a) to (c): The Ministry of Tourism has identified Gaya and Nalanda as destinations for development under Swadesh Darshan 2.0 in Bihar.

Under the scheme of “Assistance to Central Agencies for Tourism Infrastructure Development” Rs.5.18 Crore was sanctioned in the Financial Year 2013-14 for development of tourist amenities & facilities at Gaya Railway Station on 50:50 cost sharing basis with the Ministry of Railways.
