IMPLEMENTATION OF PM-KISAN SCHEME IN BIHAR

1148. SHRI SUSHIL KUMAR MODI:

Will the Minister of AGRICULTURE AND FARMERS WELFARE be pleased to State:

- (a) the number of beneficiaries of Pradhan Mantri Kisan Samman Nidhi Yojana (PM-KISAN) in Bihar, district-wise;
- (b) the amount of money provided to the farmers of Bihar so far under this scheme, district-wise;
- (c) the total number of farmers whose bank accounts are not linked with Aadhaar and National Payment Corporation of India (NPCI);
- (d) the number of ineligible farmers owing to income tax payment and other reasons respectively; and
- (e) the amount recovered from the ineligible farmers and the amount that is pending?

- (a) and (b) The district-wise number of beneficiaries of Pradhan Mantri Kisan Samman Nidhi Yojana (PM-KISAN) in Bihar and amount released to them is attached at Annexure-1.
- (c) In Bihar, the total number of farmers whose bank accounts are not seeded with Aadhaar is 10,10,426. However, payments have been made to them till now.
- (d) Number of ineligible farmers in Bihar due to being Income Tax Payee is 80,300 and Number of ineligible farmers in Bihar due to other reasons is 1,14,797.
- (e) In Bihar, the amount recovered from the ineligible/income tax payee farmers is ₹5.1 Crore and the amount that is pending is ₹241.2 Crore.
