BENEFITS OF PM-KISAN SCHEME FOR SC/ST FARMERS

1150. SHRI SANDOSH KUMAR P:

Will the Minister of Agriculture and Farmers Welfare be pleased to State:

- (a) the amount of money given to SC and ST farmers under the Pradhan Mantri Kisan SammanNidhiYojana (PM-KISAN) since its inception, State-wise;
- (b) whether Government is making any special efforts to integrate maximum number of poor farmers belonging to SC/ST community into this scheme; and
- (c) whether there is any mechanism to ensure that poor farmers from SC/ST communities are aware of the scheme?

ANSWER

MINISTER OF AGRICULTURE AND FARMERS WELFARE (SHRI NARENDRA SINGH TOMAR)

- (a): The State-wise details of amount of money given to SC and ST farmers under the Pradhan Mantri Kisan Samman Nidhi Yojana (PM-KISAN) since its inception is attached at Annexure-1.
- (b) & (c): The target of the Department is to achieve 100% saturation by enrolling every eligible farmer family of the country, including SC/ST communities under the PM-KISAN Scheme. The States/UTs have been directed to conduct various saturation drives for enrollment of potential beneficiaries under PM-KISAN. The State Governments have been continuously requested and vigorously pursued for completing the above exercise in mission mode by organizing camps.

The States/UTs have organized publicity/awareness camps to ensure maximum enrolments under the Scheme. Further, a Farmers' Corner has been created on PM-KISAN portal which provides farmers with the facility of self-registration, checking beneficiary status etc. Common Service Centres (CSCs) have also been engaged to provide all the facilities available through farmers' corner including registration of new beneficiaries and also to do publicity of the Scheme and create awareness at the ground level.

To ensure that all farmers are aware of the Scheme and ensure their enrollment, a provision has been made in the Operational Guidelines of the Scheme to publish the lists of eligible beneficiaries at the village level.
