EMPOWERMENT OF WOMEN FARMERS THROUGH ICT TOOLS

1159. SMT SANGEETA YADAV :

Will the Minister of AGRICULTURE & FARMERS WELFARE be pleased to state:

- (a) steps taken by Government for empowerment of farmers, particularly women farmers, through tools of Information, Communication and Technology (ICT) during last three years and current year;
- (b) steps taken by National Research Centre for Women in Agriculture (NRCWA), Indian Council for Agricultural Research (ICAR) for using sms/IVR and mobile for providing agricultural and weather bulletin to farmers in last five years;
- (c) number of beneficiaries through ICT tools, especially women farmers during last three years, year-wise, State-wise; and
- (d) whether any study about participation of women folk in agricultural research has been made in last five years, if so, major findings thereof?

ANSWER

THE MINISTER OF AGRICULTURE AND FARMERS WELFARE

(SHRI NARENDRA SINGH TOMAR)

(a) & (b) : The Government has taken several initiatives for providing information to the farmers including women farmers by utilizing modern information technology, which includes :

(i) Development of Kisan Suvidha mobile application to facilitate dissemination of information to farmers on the critical parameters viz., Weather; Market Prices; Plant Protection; Input Dealers (Seed, Pesticide, Fertilizer); Farm Machinery; Soil Health Card; Cold Storages & Godowns, Veterinary Centres and Diagnostic Labs.

(ii) Unified Mobile Application for New-age Governance (UMANG), developed by Ministry of Electronics and Information Technology (MeitY) and National e-Governance Division (NeGD) provide agriculture related services including assistance to farmers under high yielding programme, assistance to farmers for promotion of horticulture crops and high value agriculture, development of minor irrigation, soil conservation work and strengthening of soil testing laboratories, etc.

(iii) Under Pradhan Mantri Kisan Samman Nidhi (PM-KISAN) Scheme, fund is directly transferred into the bank accounts of the eligible farmers under Direct Benefit Transfer mode. Farmers can do their self-registration through the Farmers Corner in the

portal. PM-KISAN Mobile App was launched to broaden the reach of the scheme where farmers can view the status of their application, update or carry out corrections of name based on their Aadhaar card and also check history of credits to their bank accounts.

(iv) Launching of e-National Agriculture Market initiative to provide farmers an electronic online trading platform.

(v) Government is providing advisories services on various crop related matter to the registered farmers through SMSs using m-Kisan Portal.

(vi) Agriculture related information is provided to the farmers through Kisan Call Centre.

(vii) The Indian Council of Agriculture Research (ICAR) has compiled various mobile apps developed by ICAR, State Agricultural Universities and Krishi Vigyan Kendras and uploaded on its website. These mobile apps developed in the areas of crops, horticulture, veterinary, dairy, poultry, fisheries, natural resources management and integrated subjects, offer valuable information to the farmers, including package of practices, market prices of various commodities, weather related information, advisory services, etc. ICAR has also created an electronic platform 'Kisan Sarathi' for supporting agriculture at local niche with national perspective to provide a seamless, multimedia, multi-ways connectivity to the farmers with the latest agricultural technologies, knowledge base with pool of large number of Subject Matter Specialists.

(viii) Central Institute for Women in Agriculture (CIWA), Bhubaneswar under Indian Council of Agricultural Research (ICAR), New Delhi has developed Gender Knowledge System in Agriculture (GKS) Portal (<https://www.icar-ciwa.org.in/gks/>) based on gender disaggregated data, technologies and methodologies . ICAR-CIWA is also utilizing the social media platforms and Gender Knowledge system portal for spreading its reach towards its stakeholders.

(c): The number of women farmers benefitted under PM -KISAN year wise, State-wise under the Direct Benefit Transfer (DBT) mode during the last three years is given in Annexure .

(d): No specific study about participation of women folk in agricultural research has been made in last five years.
