(b): Since inception of the Scheme, an amount of ₹ 8969.47 crores (upto 30.11.2022) has been disbursed to the sugar factories as SDF Loans as per details given below :

(c) & (d): With the approval of Department of Expenditure, Ministry of Finance, the schemes for providing financial assistance to the sugar factories have been closed forthwith vide order dated 21.09.2021.

(e) & (f): Since inception a net cess amount of ₹12,834.44 crore has been collected (up to 30.06.2017, as cess was abolished by Central Government on introduction of Central Goods and Services Act, 2017). Out of this, till 31.03.2018, an amount of ₹10195.52 crore was transferred to the Sugar Development Fund and was utilised for various schemes under SDF Act, 1982 and SDF Rules, 1983. The balance in the cess account has been transferred to the Consolidated Fund of India.
