**PHARMA SPECIFIC SKILL DEVELOPMENT TRAINING IN TELANGANA**

123. SHRI B. PARTHASARADHI REDDY:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) whether Government has any plans to provide sector specific pharma related skill development training to youth of Telangana;
- (b) if so, the details of the initiatives undertaken by Government for the training of youth in the pharma sector in Telangana;
- (c) the details of the youth trained in pharma sector during the last three years, year-wise, State wise, and district-wise for Telangana; and
- (d) the details of the funds sanctioned, released and utilized in this regard during the last three years, year-wise, State-wise and district-wise for Telangana?

**ANSWER**

THE MINISTER OF STATE IN THE MINISTRY OF SKILL DEVELOPMENT AND ENTREPRENEURSHIP

(SHRI RAJEEV CHANDRASEKHAR)

- (a) Ministry does not have any specific pharmaceutical sector related skill development programme for the youth of Telangana. However, training is provided in Life Sciences sector including pharmaceutical under the Pradhan Mantri Kaushal Vikas Yojana (PMKVY) as per skilling requirements of industry.
- (b) Under Pradhan Mantri Kaushal Vikas Yojana (PMKVY), since 2016, around 7 thousand candidates have been trained / oriented under Life Sciences sector including Pharmaceutical in the State of Telangana.
- (c) The State/UT-wise and year-wise number of candidates trained/oriented in Life Sciences sector including Pharmaceutical under PMKVY in last three years (i.e., 2019-22) is given at *Annexure I*.

The district wise number of candidates trained/oriented in Life Sciences sector including Pharmaceutical under PMKVY in the State of Telangana in last three years (i.e., 2019-22) is given at *Table A of Annexure II*.

- (d) Under PMKVY, there is no provision of sector specific disbursements of the funds. Ministry disburses the funds to implementing agencies, namely, National Skill Development Corporation for Central component and State Govt. / State Skill Development Mission for State component for implementation of PMKVY scheme across various sectors including Life Sciences sector. The State/UT-wise and year-wise funds utilized under central component of PMKVY in last three years (i.e., FY 2019-22) is given at *Annexure III*. The district-wise details for State of Telangana are given at *Table B of Annexure II*.
