STATUS OF IMPLEMENTATION OF MFP SCHEME

1240. SHRI RAJENDRA GEHLOT:

Will the Minister of *FOOD PROCESSING INDUSTRIES* be pleased to state:

- a) the status of implementation of Mega Food Park (MFP) scheme and the number of jobs likely to be created under the scheme, the details thereof;
- b) the number of MFPs functional in the country, State-wise especially in State of Rajasthan;
- c) the details of objectives and guidelines relating to setting up of MFPs and the extent to which the objectives have been achieved;
- d) whether Government has received any proposals for setting up MFPs from various States especially from Rajasthan during the last three years and the current year; and
- e) if so, the details thereof and the action taken thereon?

ANSWER

THE MINISTER OF STATE FOR FOOD PROCESSING INDUSTRIES
(SHRI PRAHLAD SINGH PATEL)

a) The Ministry of Food Processing Industries (MoFPI) has been implementing the scheme of Mega Food Park (MFP), a component scheme of the Pradhan Mantri Kisan SAMPADA Yojana (PMKSY), to create modern infrastructure for the food processing sector along the value chain from farm to market. A total of 41 MFP projects have been approved by MoFPI across different States/UTs. The scheme has been discontinued by the Government with effect from 01.04.2021 with provision for committed liabilities for ongoing projects. Each MFP project is likely to create about 5000 jobs once fully operationalized.

b) Out of 41 MFP projects approved, 23 MFP projects are operational, including one project in Rajasthan. State-wise details of these operational parks is given at **Annexure-I**.

c) The MFP scheme is aimed to provide modern infrastructure facilities for food processing along the value chain from the farm to the market, including creation of processing infrastructure near the farm, transportation, logistics and centralized processing centers, on a cluster based approach. The scheme is demand-driven and facilitate food processing units to meet environmental and safety standers.

Processing capacity of 15.42 lakh MT and preservation capacity of 28.57 lakh MT has so far been created.

d) & (e): 20 proposals were received during last three years for setting up of MFP projects including 2 proposals from Rajasthan. Out of these 20 proposals, 4 proposals have been approved by MoFPI including one proposal in Rajasthan. Details of proposals sanctioned during the last 3 years is at **Annexure-II**.
