PROPER IMPLEMENTATION OF SKILL DEVELOPMENT OF THE YOUTH

128. SHRI SANJAY RAUT:

Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:

- a) the schemes being implemented by Government for the skill development of the youth, particularly those youth living below the poverty line in backward and remote areas of Maharashtra and if so, the details thereof.
- b) the number of training programmes organized, and the total number of persons/youths trained under this scheme during each of the last three years and the current year;
- c) whether these trained youth have been provided employment and the district-wise details thereof; and
- d) the total funds allocated to Maharashtra under this scheme.

ANSWER

(a) & (b): Under Skill India Mission, the Government of India is implementing more than 40 programmes through 20 Central Ministries/Department for skill development for youths including youth living below poverty line across the country including the State of Maharashtra. Brief description of schemes being implemented by MSDE is as under:

Pradhan Mantri Kaushal Vikas Yojana (PMKVY): Under the scheme, skill training is provided to youth belonging to all sections of the society including BPL category, in various sectors as per the need of the market demand.

Jan Shikshan Sansthan (JSS): Jan Shikshan Sansthan (JSSs) are imparting skill training to no literate, neo-literates, persons with rudimentary level of education upto 8th and school dropout's upto 12th standard in the age group of 15-45 years in rural areas and urban slums. The priority groups are women, SC, ST, minorities, and other backward sections of the society.

National Apprenticeship Promotion Scheme (NAPS): This Scheme is for promoting apprenticeship training and increasing the engagement of apprentices by providing financial support to industrial establishments undertaking apprenticeship program under The Apprentices Act, 1961.

Craftsmen Training Scheme through Industrial Training Institutes (ITIs): This scheme is for providing long-term training through Industrial Training Institutes (ITIs) operational across the country. number of skill training courses covering a large/The ITIs offer a range of vocational -economic sectors with an objective of providing skilled workforce to the industry as well as self employment of youth.

Details about number of training centres as on 30.09.2022 and number of persons trained during 2019-20 to 2022-23 (upto 30.09.2022) pan India and Maharashtra is at **Annexure-I**.

(c) Amongst the schemes of the MSDE, placements is specifically tracked under PMKVY. Under PMKVY, 24.30 lakh candidates have been provided employment upto September 2022. The details of the youth placed under PMKVY, for the State of Maharashtra from 2019-20 to 2022-23 (upto September 2022) is placed at **Annexure-II**

As per the third-party evaluation reports of other said schemes, there is success in terms of placement or enhancement of income of candidates trained. As far as the employment of the JSS scheme beneficiaries is concerned, third party evaluation report of the scheme has mentioned, "It is finally observed that as an impact of the training programme conducted at JSSs, the self and wage employment and private job have become evident". The usefulness of the scheme would be further self-evident from the fact that same report has mentioned that 77.05% of the beneficiary trainees have undergone occupational shifts. The final report of Tracer Study of ITI Graduates (published in January 2018 by the Ministry of Skill Development & Entrepreneurship, GoI) mentions that 63.5% of total ITI pass-outs got employed (wage+ self, out of which 6.7% are self-employed).
