Transfer of additional levy to States

1314. SHRI RAJEEV SHUKLA:

Will the Minister of COAL be pleased to state:

- (a) the details of total quantum of funds collected as additional levy by the Centre from coal blocks;
- (b) the details of funds that are to be transferred to the States, State-wise, including Chhattisgarh;
- (c) whether the State of Chhattisgarh is owed additional levy to the tune of ₹ four thousand crore; and
- (d) by when Government plans to transfer the said funds?

ANSWER

- (a): Total Funds received as additional levy from coal blocks is Rs.6967.30 crores. The details of funds collected as additional levy from coal blocks is attached as Annexure.
- (b) to (d): The issue of additional levy accruing either to Central Government or to State Government concerned was examined in consultation with Ministry of Finance and Ministry of Law & Justice. Department of Legal Affairs, Ministry of Law & Justice was requested to obtain the opinion of Ld. Additional Solicitor General (ASG) in the matter. Ld. ASG of India has opined that the amount would not accrue to the State Governments. However, in the meantime, the Government of Chhattisgarh has filed an Original Suit No. 5 of 2021 under Article 131 of the Constitution of India in the Hon'ble Supreme Court.
