SALIENT FEATURES OF PM SVANIDHI

NO.1346. SHRI RAJENDRA GEHLOT:

Will the Minister of HOUSING AND URBAN AFFAIRS be pleased to state:-

- (a) the salient features of Pradhan Mantri Street Vendors Atmanirbhar Nidhi (PM SVANidhi) Yojana;
- (b) the number of beneficiaries so far covered under the PM SVANidhi Yojana in Rajasthan, district-wise details thereof and the total amount released under it; and
- (c) whether Government has been successful in achieving the objectives of PM SVANidhi Yojana, for which this scheme was introduced, if so, the details thereof, if not, the corrective measures taken in this regard?

ANSWER THE MINISTER OF STATE IN THE MINISTRY OF HOUSING AND URBAN AFFAIRS (SHRI KAUSHAL KISHORE)

- (a): Ministry of Housing and Urban Affairs (MoHUA) has launched the Prime Minister Street Vendor's AtmaNirbhar Nidhi (PM SVANidhi) Scheme on June 01, 2020 with the aim to facilitate collateral free working capital loan to street vendors to restart their businesses, which were adversely impacted during the Covid-19 pandemic. The salient features of the scheme are:
 - i. Facilitate collateral free working capital loan up to ₹10,000 with enhanced loan of ₹20,000 and ₹50,000 in the second and third tranches respectively, on repayment of earlier loans.
 - ii. Incentivize regular repayment, through interest subsidy @ 7% per annum; and
 - iii. Reward digital transactions, by way of cash back up to ₹1,200 per year

- (b) As on December 08, 2022, total 67,356 beneficiaries have been covered under the PM SVANidhi Yojana in the State of Rajasthan and ₹74.68 Cr have been disbursed. The district-wise details of beneficiaries and amount disbursed is at **Annexure-I.**
- (c) Yes, Sir. PM SVANidhi Scheme has been successful in achieving its objective of facilitating credit, to the Street Vendors to restart their business and ensuring their financial inclusion in formal economy. As on December 08, 2022, total 38 lakh loans amounting to ₹4,405 Cr. have been disbursed under PM SVANidhi Scheme through various Lending institutions.
