FLOOD AFFECTED HOUSES ACROSS WEST BENGAL

NO. 1350. DR. SANTANU SEN:

Will the Minister of Housing and Urban Affairs be pleased to state:

- a) the details of allocation and utilization of funds for flood and cyclone affected houses across West Bengal since 2017, year-wise, district-wise details;
- b) the details of the sanctioned and released funds under PMAY-U for west Bengal as well as across the country since 2017, year-wise, State-wise;
- c) whether Government has conducted any study on the environmental consequences of construction of houses in ecologically sensitive regions across West Bengal, if so, the details thereof;
- d) if not, the reasons therefor; and
- e) details of the timeline for conducting a new study on ecological consequences due to the construction of houses in ecologically sensitive regions across West Bengal?

ANSWER

(a) : 'Land' and 'Colonization' are State subjects. Therefore, respective States/ Union Territories (UTs) have to address the housing needs of its population. However, Ministry of Housing and Urban Affairs, under the vision of 'Housing for All', supplements the efforts of States/ UTs by providing Central assistance under Pradhan Mantri Awas Yojana- Urban (PMAY-U) for construction of houses in the urban areas of the country including those in West Bengal. All beneficiaries/families in urban areas including those affected by floods and cyclone are eligible to avail benefits under the scheme, if otherwise found eligible as per scheme guidelines. The houses under the scheme are sanctioned based on the project proposals received from respective State/ UT Governments as per requirement assessed by them.

District-wise and year-wise details of Central assistance sanctioned and released in the State of West Bengal since 2017 to till date under PMAY-U are given at Annexure I.

(b) : The State-wise and year-wise details of central assistance sanctioned and released since 2017 under PMAY-U (including in the State of West Bengal) are given at Annexure-II.

(c) to (e): No Sir. Projects sanctioned under PMAY-U are implemented by the State Government concerned through their Urban Local Bodies/ Implementing Agencies and as such no such study has been conducted for projects approved for release of admissible central assistance under the scheme.
