1395. SHRI DAMODAR RAO DIVAKONDA:

Will the Minister of MICRO, SMALL AND MEDIUM ENTERPRISES be pleased to state:

- (a) the number of beneficiaries in various categories of Micro, Small and Medium Enterprises (MSMEs) under Emergency Credit Line Guarantee Scheme (ECLGS), Statewise;
- (b) whether eligible and COVID-19 affected MSMEs in Telangana have been provided incentive under ECLGS and if so, the details thereof; and
- (c) the number of MSMEs owners from Telangana who are selling properties to regularize their current loans and to make re-investment in their business?

ANSWER

MINISTER OF STATE FOR MICRO, SMALL AND MEDIUM ENTERPRISES (SHRI BHANU PRATAP SINGH VERMA)

- (a) & (b): Emergency Credit Line Guarantee Scheme (ECLGS) is being implemented by National Credit Guarantee Trustee Company Limited (NCGTC) under the aegis of Department of Financial Services (DFS), Ministry of Finance. As reported by NCGTC, the state-wise number of MSMEs benefitted under ECLGS including the State of Telangana till 30.11.2022, since its inception is at **Annexure I.**
- (c): As the MSMEs function in both formal as well as informal sectors, data on properties sold to regularize current loans and re-investment are not maintained by the Government of India in the Ministry of MSME.
