PRODUCTION OF CRUDE OIL AND NATURAL GAS

1409. SHRI SUSHIL KUMAR MODI:

Will the Minister of PETROLEUM AND NATURAL GAS be pleased to state :-

- (a) the production of crude oil and natural gas, respectively, in the last five years, State/UT-wise, year-wise;
- (b) the profits recorded by public oil companies on sale of crude oil in the last three years, year-wise;
- (c) the amount collected by Government via special additional excise duty on crude oil, aviation turbine fuel exports and diesel, company-wise in Q-1, Q-2 in FY-23; and
- (d) the latest revisions made by Government in the special additional excise duty on crude oil, export of aviation turbine fuel and diesel?
