ENROLLMENT OF FAMILIES UNDER ABPMJAY

1526. SHRI JOSE K. MANI:

Will the Minister of **HEALTH AND FAMILY WELFARE** be pleased to state:

- (a) whether Government has the details of total families enrolled under Ayushman Bharat - Pradhan Mantri Jan Arogya Yojana (ABPMJAY);
- (b) if so, the details thereof, State-wise;
- (c) whether Government has noticed that the current allocation of Grant-in-aid made by the National Health Authority (NHA) for the implementation of ABPMJAY in Kerala is way below 60 per cent of total expenditure;
- (d) if so, the reasons therefor;
- (e) whether Government will consider the allocation of 60 per cent of actual expenditure incurred on treatment of Central category families (RSBY/SECC) under the scheme; and
- (f) if so, the details thereof?

(a) to (f): State/UT-wise details of eligible beneficiary families and Ayushman cards issued under Ayushman Bharat – Pradhan Mantri Jan Arogya Yojana (AB-PMJAY) are at Annexure. Funds are released to States/UTs as per the prescribed funding pattern of Ministry of Finance viz. 60:40 and 90:10, as the case may be. Central share of premium in the prescribed ratio is subject to annual ceiling of Rs. 1052 per beneficiary family or actual rate of insurance premium, whichever is less.
