Under NHM, Performance Audit is conducted by the Comptroller and Auditor General (CAG) of India. Annual Statutory Audit is conducted by Chartered Accountant firms empanelled with C&AG and eligible for conducting audit of major PSUs. CA firms are also appointed to conduct Concurrent Audits.
