- (a) the number of approved beneficiaries of Ayushman Bharat Yojana and the number of golden cards created in different States and Union Territories of the country in proportion to their population and the total number of beneficiaries of the scheme and the average payment per beneficiary during the last three years in different States and UTs; and
- (b) whether certain States have not implemented the scheme or they have implemented the scheme at their own level, if so, the details thereof?
