PRE-MATRIC SCHOLARSHIP FOR MINORITIES

1668. DR. JOHN BRITTAS:

Will the Minister of MINORITY AFFAIRS be pleased to state:

- (a) whether it is a fact that Government has decided to modify or limit pre-matric scholarships for students belonging to minority communities;
- (b) if so, the details thereof and reasons therefor;
- (c) the number of students covered by the scheme during last five years and the amount spent thereon;
- (d) the year-wise and State wise details thereof; and
- (e) the number of students proposed to be included in the scheme as per the new amendments?

ANSWER

THE MINISTER OF MINORITY AFFAIRS (SHRIMATI SMRITI ZUBIN IRANI)

- (a) & (b): Ministry of Minority Affairs implements Pre-Matric Scholarship Scheme for students from weaker economic background belonging to the 6 notified minority communities, namely, Buddhist, Christian, Jain, Muslim, Parsi and Sikh. The coverage under the scheme has been modified from 2022-23 and made applicable for classes IX and X only as the Right to Education (RTE) Act, 2009 provides for free and compulsory elementary education (classes I to VIII) to each and every child. This modification has also been done to harmonize the Scheme with the identical Scholarship Schemes implemented by Ministry of Social Justice & Empowerment and Ministry of Tribal Affairs.
- (c): During the last five years (from 2017-18 to 2021-22) 2,75,21,889 students have been sanctioned scholarships and ₹6288.85crore have been spent under the Pre-Matric Scholarship Scheme.
- (d) The year-wise and State/UT-wise details of scholarships and amount sanctioned during the last five years (from 2017-18 to 2021-22) are annexed.
- (e): The number of beneficiaries under the modified Pre-Matric Scholarship Scheme of Ministry of Minority Affairs will be maintained at the same level as the number of beneficiaries of classes IX-X in the pre-modified Scheme.
