RURAL DEVELOPMENT PROJECTS IN UTTARAKHAND

1694 DR. KALPANA SAINI:

Will the Minister of RURAL DEVELOPMENT be pleased to state:

- (a) the State-wise status of all the rural development projects during the last three years and the current year;
- (b) the steps being taken to complete these projects; and
- (c) the district-wise details of funds allocated/released by the Central Government for each of the identified projects in the State of Uttarakhand during the last two years and the quantum of funds spent in each district?

ANSWER

MINISTER OF STATE IN THE MINISTRY OF RURAL DEVELOPMENT
(SADHVI NIRANJAN JYOTI)

(a): For the development of rural areas, various schemes/projects are implemented by the Ministry of Rural Development across the country. The details of these Schemes/projects are given below:

- (i) The Department of Rural Development (DoRD), Ministry of Rural Development is implementing Mahatma Gandhi National Rural Employment Guarantee Scheme (Mahatma Gandhi NREGS), Pradhan Mantri Awaas Yojana – Gramin (PMAY-G), Pradhan Mantri Gram Sadak Yojana (PMGSY), Deen Dayal Antayodaya Yojana-National Rural Livelihood Mission (DAY-NRLM), Deen Dayal Upadhyaya Grameen Kaushalya Yojana (DDU-GKY), Rural Self Employment Training Institutes (RSETI) and Shyama Prasad Mukherji Rurban Mission (SPMRM).
- (ii) The Department of Land Resources (DoLR), Ministry of Rural Development is implementing Watershed Development Component (WDC) of Pradhan Mantri Krishi Sinchayee Yojana (PMKSY) which is principally for the development of rainfed portions of net cultivated area and culturable wastelands.

Most of the schemes/programmes of this Ministry are welfare oriented and to ensure overall socio-economic development of people of the rural areas. However, the State-wise status of projects undertaken through some of the schemes of this Ministry during the last three years and the current year is given at **Annexure-I**.

(b): Ministry of Rural Development (MoRD) accords emphasis for targeted implementation of its schemes/projects. In order to ensure that the schemes reach closure, the Ministry has evolved a comprehensive multi-level and multi-format system of monitoring and evaluation of the implementation of rural development schemes, including Performance Review Committee Meetings, District Development Co-ordination and Monitoring Committee (“DISHA”) meetings, National Level Monitors (NLMs), Area Officers Schemes, Common Review Mission and Concurrent Evaluation & Impact Assessment Studies. The schemes of the Rural Development have been brought upon end-to-end transaction based MIS, which enables all the stakeholders to monitor status of schemes in a real time basis. The works are photographed with geo-tags and one time stamped. All the data of RD schemes is available on public domain. In addition to above, the Ministry has arranged for sufficient fund for completion of works and facilitate resolution of bottlenecks like forest clearance and necessary approval etc. Social Audits are also conducted for some Schemes like Mahatma Gandhi NREGS and PMAY-G. Appointment of Ombudsman is also made for attending to any grievances regarding MGNREGA works. In addition, grievance redressal is being given due attention in all schemes of the Rural Development. State specific reviews of States/UTs are also undertaken from time to time.

(c): Ministry of Rural Development releases funds to States/UTs for implementation of rural development programmes. This Ministry does not maintain district-wise data for allocation /release/expenditure of funds. The details of funds allocated/released during the last years under various rural development programmes for the state of Uttarakhand are given at **Annexure-II**.

II. DAY-NRLM

- a. This Ministry is implementing Start-up Village Entrepreneurship Programme (SVEP), a sub-scheme under the Deendayal Antyodaya Yojana–National Rural Livelihoods Mission (DAY-NRLM), with the objective to help the rural poor to set-up enterprises at the village level in non-agricultural sectors. SVEP was approved for 258 blocks in 29 States/UT. DPRs were approved 188 block upto Nov., 2022. After the DPR approval, project implementation started in these blocks. SVEP is a demand based scheme and there is no specific allocation for any State/UT. The year wise approval of DPR is as under:-
