Will the Minister of SKILL DEVELOPMENT AND ENTREPRENEURSHIP be pleased to state:-

- (a) the status of Pradhan Mantri Kaushal Vikas Yojana (PMKVY) as on 30th November, 2022 and the details of beneficiaries under the scheme;
- (b) the percentage amount that has been utilized by Government out of the allocated budget, the allocation of funds, skill-wise and State-wise; and
- (c) whether Government has been able to meet its targets as set out in the plan, if so, the details thereof and if not, the reasons therefor?

(a) Pradhan Mantri Kaushal Vikas Yojana (PMKVY) was launched in 2015 and implemented in three phases i.e. 1.0, 2.0 & 3.0. The last date of enrollment under PMKVY 3.0 was 31.03.2022. Based on the learning from implementation of earlier phases of PMKVY, Ministry has redesigned and upgraded the new version of PMKVY, i.e., PMKVY 4.0. At present, the proposal of PMKVY 4.0 has been appraised and recommended by Expenditure Finance Committee (EFC).

Under PMKVY, since inception i.e. 2015, as on 30.11.2022, 137.23 lakh candidates have been trained / oriented across the country.

(b) PMKVY (except PMKVY 1.0 (2015-16)) has two components, namely, Central component being implemented through National Skill Development Corporation (NSDC), and State component being implemented through State Skill Development Mission (SSDM)/State Governments.

Under Central component of PMKVY, there is no provision of State-wise funds allocation. Under State component of PMKVY, funds and corresponding physical targets have been allocated to the States for the implementation of scheme through SSDMs. The State component was incorporated under PMKVY from second phase of the scheme i.e. PMKVY 2.0.

The Component –wise and State-wise funds disbursed and utilized under PMKVY since inception i.e., 2015, as on 30.11.2022, are given at *Annexure*.

(c) Pradhan Mantri Kaushal Vikas Yojana (PMKVY) is a demand driven scheme. Under PMKVY, since 2015 as on 30.11.2022, 137.23 lakh candidates have been trained / oriented across the country.
