- (c) whether several ancient/historical monuments, archaeological sites and remains are under encroachment; and
- (d) if so, the details thereof and the action taken thearon?

ANSWER

THE MINISTER OF CULTURE, TOURISM AND DEVELOPMENT OF NORTH EASTERN REGION (SHRI G. KISHAN REDDY)

- (a) There are 3695 Centrally Protected Monuments/Sites in the country under the protection
- & of Archaeological Survey of India (ASI). The details are given in Annexure-I. The
- (b) monuments are regularly inspected by the ASI official/officers from time to time to assess the present condition of the monuments/sites. Necessary conservation and preservation works are taken up as per the requirement of the monument/site.
- (c) Encroachments in few protected areas of centrally protected monuments/sites have been
- & reported in the country. The details are given at Annexure-II. Action taken up by ASI
 (d) includes filing Police complaints, issuing Show Cause Notices to defaulters for removal of
- the said encroachments and issuing demolition orders to Collector requesting for demolition/removal of the said encroachments wherever necessary. The removal of encroachments is a continuous process.
